THE VINYL SIDING INSTITUTE'S IMPORTANT FIRE SAFETY **INFORMATION STATEMENT IS AS FOLLOWS:**

Exterior vinyl building materials require little maintenance for many years. Nevertheless, common sense dictates that builders and suppliers of vinyl products store, handle and install vinyl materials in a manner that avoids damage to the product and/or structure. Owners and Installers should take a few simple steps to protect vinyl building materials from fire.

TO HOME AND BUILDING OWNERS:

Rigid vinyl siding is made from organic materials and will melt or burn when exposed to a significant source of flame or heat. Building owners, occupants and outside maintenance personnel should always take normal precautions to keep sources of fire, such as barbecues, and combustible materials, such as dry leaves, mulch and trash away from vinyl siding.

TO THE BUILDING TRADES, SPECIFIERS, PROFESSIONALS AND TO DO-IT-YOURSELF INSTALLERS:

When rigid vinyl siding is exposed to significant heat or flame, the vinyl will soften, sag, melt or burn, and may thereby expose material underneath. Care must be exercised prior to installation when selecting underlayment materials because many underlayment materials are made from organic materials. All building materials should be installed in accordance with local, state and Federal building codes and fire regulations.

While Kaycan vinyl siding remains virtually maintenance free, it will become dirty as any other product which is exposed to atmospheric conditions. Normally, your Kaycan vinyl siding can be cleaned satisfactorily through the use of an ordinary garden hose. If stubborn stains cannot be removed with water, the following procedure should be used: 1. Equip the garden hose with a soft bristled, long handle car brush.

2. Where soil is of a stubborn nature, the following cleaning solution works well: • 1/3 cup household detergent

before rinsing.

- 2/3 cup trisodium phosphate
- 1 gallon of water

In certain geographic areas where mildew may be a problem, substitute one quart of 5% sodium hypochloride (household bleach) for one quart water in the above formula.

Where the house is extremely dirty, it is recommended that you start washing from the bottom and go to the top, rinsing frequently. Cleaning solutions should be permitted to stand on the surface of the siding for several minutes

Congratulations and thank you for your purchase of low maintenance, high quality **Perfection Shingles** siding by Kaycan. Our products utilize better materials and are manufactured to precise specifications so that you will experience a lifetime of trouble-free enjoyment. We are so confident in our quality; we stand behind our products with a transferable limited lifetime warranty.

TERMS

Kaycan warrants to the original homeowner/purchaser that **Perfection Shingles** siding will be free from manufacturing defects when properly installed and subjected to normal use. These defects include peeling, flaking, blistering and corrosion. Distortion caused by any source is not covered under this warranty.

Perfection Solid Colors

Kaycan also warrants to you that for eight (8) years **Perfection Shingles** siding will not excessively fade. "Excessive fading" is more than normal weathering from the elements and which exceeds a Delta E of four Hunter units, as determined by Kaycan. Perfection Rustic Collection colors (two-tone colors) excess fading is defined by a change in base color or Delta E of seven (7) Hunter unit as determined by Kaycan. Should Kaycan determine your siding has excessively faded, at Kaycan's sole option, we will either repair, replace, refinish or refund to you the value of the siding, but not to exceed the original purchase price of the siding. If original costs cannot be documented, Kaycan will determine a reasonable amount of any refund.

In the unlikely event of a claim, your replaced, repaired or coated **Perfection Shingles** siding will be covered for the remainder of the original warranty period. The lifetime coverage provided by this warranty ends upon sale of the property or death of the original owner of the property at the time of installation. Lifetime coverage, as set forth in this warranty, applies to only individual homeowners. Perfection Shingles siding purchased by or installed on property owned in whole or in part by corporations, partnerships, trusts, government agencies, schools, religious organizations, cooperative housing associations and condominiums shall be covered exclusively by the 50-Year Warranty Coverage Schedule (Figure B). Any other type of building or premises not used as a single family dwelling by the owner, including apartment buildings, shall be covered for 50 years under the provisions set forth in the 50-Year Warranty Coverage Schedule (Figure B).

During the warranty period, reimbursement for damage caused by hail must be pursued by the original homeowner/purchaser through homeowner's insurance or any other applicable insurance coverage. Kaycan will not be liable for expenses in excess of the replacement cost of materials required to replace only hail-damaged materials. This includes (a) the payment of any installation, labor, freight; or (b) the purchase of any additional siding intended to replace Product(s) not damaged by hail. Excluding insurance deductible and labor, Kaycan will reimburse expenses incurred by the claimant in excess of the amount covered by insurance. Proof of insurance claims must be provided.

TRANSFER OF COVERAGE

In the event of a change in ownership, the original purchaser may transfer the 50-Year warranty to the subsequent owner of the property. Upon transfer of the property, the siding will be covered under terms described by the 50-Year Warranty Coverage Schedule (Figure B), calculated from the date siding was originally installed. The fade protection coverage of this warranty is not transferable.

LIMITATIONS

This warranty does not provide protection against any damage, failure or defect caused by events and situations beyond normal exposure condition, including but not limited to:

- Abuse, neglect or misuse:
- Impact of foreign objects, lightning, fire, flood, hurricane, tornado or any other act of God;
- Improper installation or installation not in strict compliance with procedures outlined in the instruction manual:
- Use of accessories not specifically approved for fastening or receiving Perfection Shingles siding:
- Improper handling or storage:
- Defects in, failure of, or damage to the material or wall on which the **Perfection Shingles** siding was installed caused by distortion, movement, cracking or settling of the wall or material or the foundation of the building:
- Any cause not directly a result of manufacturing defects.
- Damage due to any reflective sources or exces-sive heat sources.
- This warranty shall not apply to any vinyl / polypropylene siding installed over foil back foam which face the siding. Installation in this manner will render it null and void.

Perfection Shingles siding is not warranted against damage caused by mildew, air pollution, and exposure to harmful chemicals/cleansers, or normal weathering from the elements. Normal weathering is defined as prolonged exposure to sunlight, atmosphere, and extremes of weather. These elements will gradually cause most colored surfaces to fade, chalk, stain and accumulate dirt. Geographic location, air quality and other factors beyond our control will govern the severity of these conditions. Normal weathering will be determined by criteria set forth by Kaycan. If the siding is determined to be weathered beyond normal expectations and is deemed defective, Kaycan will, at its discretion, coat, repair, or replace the defective siding. Kaycan reserves, at its option, the right to refund the amount paid by the original owner for the siding, accessories and a customary labor allowance (labor allowance at the sole discretion of Kavcan).

This warranty is void if the siding has been painted, varnished or otherwise coated over the original manufacturer's finish by the homeowner or unauthorized company or perons other than the manufacturers.

Kaycan reserves the right to discontinue or modify any of its products, including color, without notice to the consumer. Kaycan shall not be liable for variations in color or gloss of its product as compared to product that has experienced normal weathering. In the event that the product line is discontinued or modified, Kaycan reserves the right to substitute product designated to be of comparable price or quality. All claims must be brought to Kaycan within a two-year period.

CONDITIONS

This warranty supersedes all other warranties, liabilities and obligations; whether oral, written or implied. State laws governing the implied warranty of merchantability or fitness of a product for a particular purpose may control the time a homeowner/purchaser may seek a remedy under the terms of this warranty. Kaycan shall not be held liable for damages of any kind, whether consequential or incidental, including damage to the building structure, its contents or any persons therein resulting from breach of this warranty. Kaycan prohibits its distributors, dealers, or representatives

from changing the terms of this warranty in any way. Limitations on or exclusion of incidental or consequential damages may be prohibited by law in some states and may not apply to you.
